The Petition must be signed by legally qualified voters of the State of NJ residing in the County of Salem if the Petition is for County Office and/or residing in the Municipality if the petition is for a Municipal Office. The Petition must be signed by at least 2% of the legally qualified voters of the votes cast for Members of the General Assembly at the last preceding General Election for which nominations for the General Assembly were made in the County in the case of County Officers or in the Municipality in the case of Municipal Officers provided that no more than 100 signers are required in any case. (N.J.S.A. 19:13-5).
